Born in New Kent County, Virginia, in 1761; died 18 Jan. 1816. He taught school, and was apprenticed to a wheelwright. Before the age of twenty-one he married ELIZABETH CLARK. He was Clerk of the First Baptist Church at Charles City County, Virginia, its Deacon, and Pastor.<sup>3</sup> In 1813 this William Clopton, who had long been a leading member of the church, and seeing great need of a regular preacher, began to speak publicly, and was finally ordained to the ministry. He was representative at the Dover Association from Charles City, Virginia, Church.<sup>4</sup>

Of his six children, one was Elder James Clopton who succeeded in his father's pastoral duties.<sup>5</sup>
