Mear Sidney:

The Howell line, and the Cavanah and McKinne line connections are proving to be somewhat of a puzzle. There seems to have been two McKinney Howell's, one who took title to land in Halifax, N.C. in 1779 and the other, born 1781, who went to Georgia-also two Mathews, one of whom probably died in Halifax. There were a number named Thomas and Joseph and it is hard to distinguish with the scant data in hand. additional information probably is available in Raliegh and if that does't clear the line we may have to trace it out from the ladd descriptions. Many of the records are missing, and those available are in several different places. We'll keep you advised.

I dont know if the Joseph in Wilkes and Carren (Counties, Georgia) in 1793 and 1794, later in Warren and Hancock, was the same man. The Joseph in Hancock in 1850, then aged 79 and born in N. Carolina, may have been the brother of McKinney. Any further date you can get on him probably would help.

Thanks for the copy of the James Moore deed also the Howell abstracts - if you did not keep a copy of the latter I will return it.

Based on the notes previously sent, and on those herewith, it appears that the Howell line may have been as follows:

l. Matthew Howell of Isle of Wight County, Virginia; married Mary, daughter of Joseph Lane; died 1720; issue an unborn chilc, son Joseph, and son

2. Thomas Howell of Bertie-Edgecombe-Halifax County, N. Carolina; born 1703; married Ann ---; died 1777; issue son Villiam, and son

3. Thomas Howell of Halifax County, N. Carolina; born 1725; married ---; daughter of (? John McKinne; died 1795; insue: five daughters, (? son McKinne), and son

4. Matthew Howell of Halifax County, N. Carolina; born 1747; married Temperance; daughter of (?Charles) Cavanah of Edgecombe County, N. Carolina and Burke County, Ga. (? son) of Charles Cavanah who died 1757 in Edgecombe) died 1802; issue: Sarah (married Rhodes), sons Matthew, Thomas, Joseph, William, and son.

5. McKinne Howell of Halifax County, N. Carolina, and Greene County, Georgia; born 1781; married Mary, daughter of John Johnson; died 1851.

It is merely an assumption that the Thomas, son of Matthew of Isle of Wight, was identical with the Thomas who died in Halifax in 1777-research in the records of Isle of Wight, and of Bertie, N. Carolina, is indicated in this connection. The time element favors the conclusion, however, and the lane associations are persuasive. That the Thomas who died in 1795 was the son of the Thomas who died in 1777 is strongly evidenced by the fact that Patience Pierce, laughter of the former, witnessed the will of the latter, her grandfather. Fatience was a McKinne name. No will or record of administration of the Matthew who died in 1802 has been found, but it is obvious that he was the son of the Thomas who died in 1.95 and the father of the brothers who moved to Georgia—They sold the land for which Matthew was assessed in 1800 and for which his father, Thomas, was assessed on pror rolls. I hope to find something further regarding this Matthew on my next trip to Raliegh.

The McKinne Howell who had a deed to 320 acres in Halifax i somewhat of a puzzle. He could not have been the man who married Mary Johnson for that McKinne was not born until 1781, two years after the date of the deed. I have as med that he was a son of the Thomas who died in 1795 and that he died intestate and thout issue, his land falling first to his father, then to his brother, Matthew, and later to Matthew's sons, the Georgia Brothers, who sold it in 1806. But L. L. Knight, a his Georgia Landmarks, stated that McKinne Howell was one of the original settlers of 'reane County, Georgia. This could not have been the McKinne who married Mary Johnson—Treene County was organized in 1786—This McKinne was only five years old at that ime and he was still in N. Carolina as late as 1804, eighteen years after Greene Count, was established. Possibly the McKinne Howell referred to by Knight was the same ma who took title to the land in Halifax, N. Carolina in 1779 and then disappeared ton that section.

I have no authority for the statement that Matthew Howell married a laughter of Charles Cavenah (Cavenaugh) the younger, except the tradition in the Howell 'amily and the fact that Charles seems to have lived in Halifax before going to Georgia bout 1768 and that Matthew Howell must have married about that time. Perhaps all of the foregoing is cockeyed—please both you and Mrs. Reid write me your opinion.
